**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF SARASOTA COUNTY, FLORIDA**

**RE: ADOPTING PROPOSED COUNTYWIDE MILLAGE RATE AND PROPOSED
MILLAGE RATES FOR AD VALOREM DISTRICTS FOR FISCAL YEAR 2013.**

WHEREAS, in compliance with Chapters 129 and 200, Florida Statutes, the Sarasota County Board of County Commissioners (the "Board") conducted a duly-noticed public hearing on September 10, 2012 for the purpose of adopting the proposed countywide millage rate and the proposed millage rates for ad valorem districts for Fiscal Year 2013; and

WHEREAS, the Board has received and considered all public comments and the public has been afforded to ask questions regarding the proposed countywide millage rate and the proposed millage rates for the ad valorem districts.

NOW, THEREFORE, BE IT RESOLVED, by the Sarasota County Board of County Commissioners in public-meeting assembled, that:

1. The proposed aggregate millage rate of 3.3912 mills, which is a 0.00 percent decrease of the current year aggregate rolled-back rate of 3.3913, is hereby adopted as the proposed countywide millage rate for Fiscal Year 2013. The proposed aggregate millage rate is comprised of the following proposed millage rates which are hereby adopted:
 - A. The General Operating millage of 3.1530 mills, which is a 0.92 percent increase of the rolled-back rate of 3.1243 mills.
 - B. The Debt Service Fund millage of 0.1577 mills, which is a 33.99 percent decrease of the rolled-back rate of 0.2389 mills.
 - C. The Mosquito Control District millage of 0.0805 mills, which is a 186.48 percent increase of the rolled-back rate of 0.0281 mills.
2. The proposed aggregate millage rate of 3.3912 mills is necessary to support the tentative Countywide budget for Fiscal Year 2013, adopted pursuant to Resolution No. 2012-140.
3. The proposed millage rates for the ad valorem districts set forth below for Fiscal Year 2013 are as follows:
